

Terms and Conditions for “Free NYSE/ NYSE Arca/ NASDAQ Live Prices” Promotion

1. The “Free NYSE/ NYSE Arca/ NASDAQ Live Prices” Promotion (“Promotion”) runs from 1st January 2018 to 31st December 2018, both dates inclusive (“Qualifying Period”).
2. This Promotion is open to existing clients (“Existing Client”) with a KE Trade account with Maybank Kim Eng Securities Pte Ltd (“Maybank KES”) during the Qualifying Period.
3. The following persons are not eligible to participate in this Promotion:
 - (a) Maybank KES institutional clients;
 - (b) Employees and Trading Representatives of Maybank KES; AND
 - (c) Maybank KES account holders whose accounts have been suspended, cancelled or terminated
